First come first served. Any person interested in purchasing any of the specified residential properties (“Prospective Purchaser”) (if the Prospective Purchaser is a company, then any one of its directors) must:- <ol style="list-style-type: none"> (a) personally attend the ICC 62/F Venue; and (b) bring along his/her H.K.I.D. Card(s)/Passport(s) and cashier order(s) and (if applicable) copy of Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and secretary. The number of cashier order(s) shall be equal to the number of specified residential property(ies) to be purchased by the Prospective Purchaser. Each cashier order shall be in the sum of HK\$100,000 and made payable to “Woo Kwan Lee & Lo”; 2. For the purpose of determining the order of priority, the Vendor does not accept any person having queued up at the ICC 62/F Venue before the commencement time of sale. 3. In case of any dispute, the Vendor reserves its absolute right to allocate the specified residential properties to any person interested in purchasing by any method (including balloting). 4. Prior to the selection of the specified residential properties by the Prospective Purchaser, eligible staff within Sun Hung Kai Properties Group and their eligible family members (“Staff Registrants”) may select and purchase the specified residential properties. Staff Registrants must bring along his/her/their original H.K.I.D. Card(s)/Passport(s), the original receipt of Staff Registration of Intent and personally attend the ICC 62/F Venue between 11:00 a.m. to 11:15 a.m. Staff 	

Registrants who arrive at the ICC 62/F Venue after 11:15 a.m. shall not be eligible to participate in the selection and purchase of specified residential properties. After verification of the identity of the Staff Registrants, the order of priority in which the Staff Registrants shall select and purchase a specified residential property shall be determined by the length of service of the eligible staff (in descending order) as determined by the Vendor whose determination shall be final and absolute.

5. After the selection of units by the Staff Registrants, the Prospective Purchaser (if the Prospective Purchaser is a company, then any one of its directors) shall **personally** (or (if the Registrant is an individual) his/her/its/their attorney duly appointed pursuant to a validly executed power of attorney in a form prescribed by the Vendor (a "**duly appointed attorney**") select the specified residential properties which are still available at the time of selection in the order of priority as determined above and in an orderly manner and within reasonable time. If the Prospective Purchaser has successfully selected any of the specified residential properties, the Prospective Purchaser (if the Prospective Purchaser is a company, then any one of its directors) shall **personally** (or (if an individual) by a duly appointed attorney pursuant to a validly executed power of attorney in a form prescribed by the Vendor) enter into one or more Preliminary Agreement(s) for Sale and Purchase of the specified residential property(ies) successfully selected by him/her/it. The cashier order(s) will be used as part payment of the preliminary deposit for the purchase of the specified residential property(ies).
6. The Vendor reserves the right to close the ICC 62/F Venue at any time if all the specified residential properties have been sold out.
7. If Typhoon Signal No. 8 or above is hoisted or Black Rainstorm Warning is issued at any time between the hours of 9:00 a.m. and 8:00 p.m. on any date of the sale, for the safety of the Prospective Purchasers and the maintenance of order at the ICC 62/F Venue, the Vendor reserves its absolute right to close the ICC 62/F Venue. Details of the arrangement will be posted by the Vendor on the website (www.mountregency2.com.hk) designated by the Vendor for the Development. Prospective Purchasers will not be notified separately of the arrangement.
8. In the event of any discrepancy between the English and Chinese versions of this Sales Arrangement, the English version shall prevail.

1. 先到先得。任何有意購買指明住宅物業的人士（下稱「準買方」）（如準買方是公司，則其任何一位董事）須遵從下列程序：

(a) 親臨 ICC 62 樓會場；及

(b) 攜同其香港身份證/護照正本及本票及(如適用)商業登記證書副本及已於公司註冊處登記之文件以顯示當時的董事及秘書的名單。本票的數目需與準買方將購買的指明住宅物業的數目相同。每張本票金額為港幣 \$100,000 及抬頭人須為「胡關李羅律師行」。

2. 為決定優先次序的目的，賣方不接受出售時間開始前於 ICC 62 樓會場排隊輪候的人士。

3. 如有任何爭議，賣方保留絕對權力以任何方法（包括抽籤）分配該等指明住宅物業予任何有意購買的人士。

4. 在準買方揀選指明住宅物業之前，新鴻基地產集團內的合資格員工及其合資格的家庭成員(下稱「員工登記人」)可選購指明住宅物業。員工登記人須於上午 11 時至上午 11 時 15 分親身攜同其香港身份證/護照正本及有效的員工購樓意向登記收據正本，到達 ICC 62 樓會場。於上午 11 時 15 分後才到達 ICC 62 樓會場，員工登記人將不享有參與選購指明住宅物業的資格。在賣方核實員工登記人身份後，賣方將按員工登記人的工作年資由長至短排序以決定其選購指明住宅物業的優先次序，賣方的排序為最終及決定性。

5. 當員工登記人完成選購單位後，準買方（如準買方是公司，則其任何一位董事）須根據上述優先次序有秩序地及於合理時間內親身(或(如登記人為個人)其按賣方所規定的格式並有效地簽署的授權書所委任的授權人(下稱「妥為委任之授權人」))揀選於當時仍可供揀選的指明住宅物業。成功選擇指明住宅物業的準買方（如準買方是公司，則其任何一位董事）須親身(或(如個人)按賣方所規定的樣本並有效地簽署的授權書所委任的妥為委任之授權人)簽署一份或多份臨時買賣合約購買其成功選擇的指明住宅物業。本票將會用作支付購買指明住宅物業的部份臨時訂金。

6. 賣方保留權利在所有指明住宅物業已售出的情況下於任何時間關閉 ICC 62 樓會場。
